At the hearing into the anonymous complaint filed at the Ethics Commission charging that Hall improperly used campaign funds for personal expenses, Ethics Commissioners heard testimony from defense witnesses. But when it came time for the testimony from the prosecution's star witness, Olivia Scanlon, who had been summoned to answer questions about the discrepancy in the evidence, she plead the 5th Amendment in connection with her previous testimony in the

In September the Commission heard testimony in support of the allegations. It included charges that then Supervisor Hall had misused funds, repaying Scanlon \$12,000 from campaign funds for a personal loan that she had made to Hall,

and charges that he had bought food and gas for campaign workers and volunteers without filing the necessary paperwork, and that he purchased personal gifts for his wife and daughters with a campaign credit card in the amount of \$320.

The pivotal evidence, the checks Scanlon submitted to the Ethics Investigators as evidence of the alleged loan, came into question when it was discovered that there were two versions of the same check. One version had the notation "services" in the lower left corner, indicating the reason for the payment, the other check, bearing the same number and contained in the official exhibit at the trial, had no such notation, which led to

Star Witness Against
Tony Hall Pleads the 5th!

Olivia Scanlon, the Ethics Commission's star witness against Tony Hall in their 3 year long effort against the former District 7 Supervisor, plead the 5th Amendment against self-incrimination on the least the self-incrimination on the least terms. against self-incrimination as the hearing progressed on October 27. She was a former Aide to Hall.

Scanlon, who also serves as an Aide to Supervisor Sean Elsbernd, appeared at the hearing in response to a subpoena from Hall's attorney David Waggoner. He had earlier filed a criminal charge against Scanlon that alleged she tampered with evidence, as reported in the September Observer.

> the questions surrounding the evidence which precipitated the criminal charges brought against Scanlon for tampering with evidence. Commissioners and the Ethics leadership continue, however, to press on with the hearings into the matter in spite of the shaky evidence.

> Hall noted the cost to the people of the City for the hearings, "it is unfortunate, because the taxpayers are also the victims of this over-zealous prosecution. With four City employees working on this case for the last three years—when

that time is tallied—the expense may well be over a million dollars. I know there are better uses for hard-earned tax dollars. This incredible attack on my character is unprecedented, as far as I know. I remain confident that the Commission will make the right decision, but there has to be bet-

ter oversight of shenanigans like this. I hope the Ethics Commission will get its priorities clear to assure the public that it is not driven by political agendas."


At the hearing, Commissioners heard Peter Fatooh testify that Scanlon had misused theater tickets he had secured to be used as gifts to campaign volunteers and donors and, he said, that he stopped helping the campaign because she had used them herself. He said he "stopped taking her calls," because "she lied about their use."

Contractor Michael Buckley testified that he had considered hiring Scanlon's husband, Seamus Cudden, as a subcontractor, but refused to pay

obligation bond to enable construction of the California High Speed Rail Project. Proposition 1A, which you will find in the slim Supplemental State Voter Information Guide, constitutes the financial foundation for the first phase of the Project from San Francisco to San Jose across the Pacheco Pass to Merced, Fresno and Bakersfield in the Central Valley, then to Palmdale, downtown Los Angeles' Union Station (in 125 minutes) and Anaheim's new transportation center (in another 20 minutes) at a cost of \$33,000,000,000. With voter approval of Proposition 1A, design and engineering can be completed in 2009, construction begun in 2010 and the 220-mile-per-hour high speed train will be ready for usage to Los Angeles and Anaheim by 2018, with the possibility that segments such as San Francisco to San Jose in 30 minutes and Los Angeles to Anaheim in 20 minutes may be opened earlier.

As Chairman of the California High Speed Rail Authority, I am convinced that starting in 2009 the Congress and President of the United States will enact legislation providing at least \$11,000,000,000 and perhaps as much as \$17,000,000,000 to defray the first phase's cost, with private investors (including pension systems such as the California Public Employees Retirement System) furnishing the balance of capital expenditure. Already, in early October President Bush signed a rail transportation bill which

#### **Get Dirty**

Hatchet-wielding overpaid City hall bureaucrats have quietly devised and implemented a plan to cut the annual costs of street cleaning by weaning the West Side of San Francisco from weekly street cleaning to twice a month.



The eastern side of the city will continue to receive weekly street cleaning, sources say.

The new plan will primarily affect Districts 2, 4 and 7.

These areas will be cleaned only on the first and third weeks of the month, rather than weekly. The abbreviated street cleaning program launched in August. Adhesive stickers were produced for the Dept. of Parking and Traffic to stick on the current street signs giving city warnings to move your cars on a street-cleaning day. Put up on the West Side of town only, the stickers advise residents that street cleaning will now happen only twice a month in their area.

Only 20,000 stickers were ordered, so it is clear that they were not designated for citywide signs.

The recommendation that the West Side of San Francisco be left dirty twice a month came from a private consultant firm hired by the city, according to sources. The cost of the consulting contract has not been ascertained.

There appears to be elements of class analysis and voter ballot box power in the independent consultant's recommendation to leave the greater west side of town to clean up its own streets. The presumption appears to be that west side home owners are more tidy than east side renters, thus can manage better without the city's traditional weekly street cleaning. The west side has far more individual homeowners and taxpayers who historically have carried the burden of tax bonds regularly approved by the majority of renters on the city's east side. And they get less street cleaning for their money?

But wait, as the annoying voice-over intones in those late night tv infomercials says, there is more:

The wankers at Dept. of Parking and Traffic apparently remain undecided about which other neighborhoods in addition to the Westside prime victims will get half the street cleaning they pay for. There has even been a turf war between DPW and the Dept. of Signs (or whatever the hell it is called) over who gets to put the stickers on the Street Cleaning signs. DPW could have done it more efficiently, but the Signs geniuses won that tug of war, costing the city more for the process of putting up the stickers saying Only Every Other Week (mark your calendars well!) - but the stickers don't stick very good and cherished O.T. may be required for this folly.

Such intermural city department turf wars are nothing new. I recall growing up near 14th and Vicente and when you walked up the hill to Taraval to catch the L streetcar there was always sand all over the streets, piling up in the gutters and blowing in your eyes with the slightest of winds. The streetcars in those days dropped sand to apparently help the breaks break, don't ask me why. I asked a city worker why no one cleaned up the annoying sand and was told that DPW said it was the Muni's responsibility because they dropped the sand, and the Muni said it was DPW's job because the sand was gathered along the sidewalk — so — Stalemate! — no one cleaned up the sand.

Back to late nite tv ads, There Is Still More! As the wingnut planners continue to cut costs (some residents who park on the street remain grateful for one less possible street cleaning ticket a month, there is always some good to come from the bad) the same DPW gang is busy sending out the trash can police to REMOVE as many trash cans as they can from the sidewalks. The rationale here appears, absurdly, that people will thereby not put their home garbage in the trash cans, thereby depriving the monopoly garbage collectors from their two pence, a high charge from which the city does not get anywhere near its fair piece for awarding the monopoly contract. (Dare ask Quentin Kopp about this and he will chock in anger and his valued civic life will be imperiled, so don't raise this sore issue of garbage rates with the dear old peanut.)

An unscientific inspection of some of the remaining trash cans that haven't been disappeared by DPW zealots shows evidence not of household garbage but of greasy McDonald wrappers, Starbucks cups, bags of doggie poopie and the like that even good citizens are unlikely to carry with them for blocks when there is no trash can to dump such in. So where does it now go? The streets.

In sum: The brainiac who came up with this idea wanted to save money and keep the streets just as clean as when they were dirty. This is city planning at its best. There will be less street sweeping and at the same time fewer trash cans to put the trash into. This is supposed to keep things clean. As Chico Marx said, "Who are you going to believe, me or your own eyes?"

If the San Francisco General Hospital were to close down, where would Mr. Wooding be taken following a serious accident or injury?

San Francisco General Hospital (SFGH) is the only trauma center serving our city, treating over 3,600 critically injured San Franciscans annually. As physicians we know that if we were injured, no other facility in San Francisco could match the expert care we would receive at SFGH. The nearest medical centers offering equivalently

trained staff and specialty surgeons available around the clock are located in Sacramento and Palo Alto.

In these tight financial times, Proposition A offers San Francisco the most affordable means to rebuild our trauma center to new seismic standards. General obligation bonds that would be authorized by prop A have the lowest interest rates, therefore minimizing taxpayer money wasted on interest payments while preserving cash to fund other vital city services. Each year construction is delayed, costs are estimated to rise an additional 40 million dollars.

Reagan Revolution, RIP

In his book, "The Crisis of Global Capitalism," legendary investor George Soros warned that free markets needed to be supervised by a force more powerful than corporations or they would reel out of control.

Soros was prescient: "I argue that the current state of affairs is unsustainable. Financial markets are inherently unstable and there are social needs that cannot be met by giving market forces free rein."

Nevertheless, Republicans have preached the virtues of deregulation

since Ronald Reagan routed Jimmy Carter in 1980. Moreover, they have demonized government's role as watchdog of the public interest.

Republicans so successfully undermined the vital importance of good government that they forgot how to govern in a stark emergency like Katrina. They have essentially asserted that unfettered markets would transform the world by seeding democracy and employing the planet into middle class prosperity, while deriding the concept that a powerful arbiter must protect the common good.

A blind promise to lower taxes is the primary Republican domestic platform. Frankly, it's little more than a bribe that promises the nation prosperity and preeminence without an honest assessment of the money needed to sustain these high standards.

By shrilly opposing spending on vital investments such as education and infrastructure renewal, Reagan's ideological progeny have unwittingly damaged America's competitive edge. Today, our schools and vital assets like roads, bridges, airports, ports, transit systems and broadband networks are being trumped by numerous countries throughout the world.

But it gets worse. Now, the taxpayer trillions needed to douse the inferno on Wall Street will accrue interest, which must be paid by our kids. There will be even less capital available for the infrastructure and social needs of the future

Meanwhile, as they have for decades, Republicans continue to stoke the flames of cultural and religious differences to cover up their total lack of a credible formula for sustainable economic progress.

The GOP's complete absence of affirmative intellectual leadership on major domestic issues is beginning to

show: Democrats are poised to take the White House, add 15-20 seats to their House majority and possibly reach a supermajority in the Senate.

Americans now see that the Repub-

lican no-new-tax mantra flies in the face of a glaring need for public investment. Like the stubborn owner who refuses to invest in new equipment and worker training, Republicans are bankrupting our country through a lack of vision and bad management.

The present financial crisis presents a moment

for sober reflection: What has "hands-off" government wrought?

Huge concentrations of capital cannot be left to their own regulatory devices. The propensity for selfishness is overwhelming. As evidence, the entire global free enterprise system has been inadvertently jeopardized through laissez-faire regulatory policies. The trail of greed is as obvious as pig tracks in the mud. It is precisely because human beings inevitably pursue their own selfish interests that a greater authority is necessary to promote the common good.

Government must protect the public interest. This is precisely the philosophy adopted by Franklin Roosevelt and the Democratic Party, which pulled America out of the Great Depression and into world economic hegemony for the remainder of the 20th century. On domestic issues, the Republican Party since Reagan has been a reactionary institution. The agenda has simply been to peel back the excesses of so-called "Big Government."

2008 will mark the final passing of that reactionary Republican agenda and its public face – the Reagan Revolution. The simultaneous emergence of the credit crisis and a momentous presidential election forces Americans to evaluate not just two candidates, but also two governing philosophies.

The trillion-dollar bailout marks the end of the line for Ronald Reagan's bankrupt domestic governing philosophy. Now Franklin Roosevelt, Harry Truman, John Kennedy and Lyndon Johnson can rest in peace.

### **General Hospital Rebuild Bond**

San Francisco General Hospital, the city's only trauma center and heart of losing the trust of the San Francisco our health care system, must be rebuilt

to meet state seismic standards or close as early as 2013. The fate of General Hospital is something in which we all have a stake. Proposition A represents the most costeffective way to finance this necessary and worthy civic endeavor.

Prop. A will authorize

San Francisco to raise \$887.4 million for a new acute care hospital building with an expanded emergency department and more room for patient care – and without raising your taxes. It's endorsed by the Democratic, Republican and Green parties, the San Francisco Chronicle, Examiner and Bay Guardian newspapers, the Chamber of Commerce, Labor Council, Medical Society and Hospital Council, Senator Dianne Feinstein, Mayor the Board of Supervisors.

The bond measure to rebuild is prudent and broadly supported because of the care that has gone into designing, planning and preparing the new hospital building and the financing program to pay for it. The rounded design - with two stories below ground and seven above - maximizes space for patient treatment and workplace safety, and is based on industry best practices. Preconstruction pricing and regulatory approvals were obtained to avoid cost increases due to delay. Careful scheduling means bonds for the new General Hospital will be issued as bonds for earlier projects are retired, resulting in no net increase in property taxes.

All of San Francisco has a direct interest in the mission of San Francisco General. As the city's only Level One trauma center, General is solely Cont. p. 4

Ask yourself, when was the last time

San Francisco did a good job on a bond measure? How many Laguna Honda Hospital rebuilds do you want to be taxed for?

According 6/26/08 Civil Grand Jury report, "Accountability in San Francisco Govern-

ment," San Francisco's bond measures are averaging between 35% to 67% in cost overruns. The Jury's report documents horrendous City bond oversight, concluding: "The ultimate response to the lack of accountability and oversight is for the voters to demand better governance from City officials. In the meantime, there are no standard operating procedures to hold departments and commissions accountable [for bonds] and, by extension, no accountability by Gavin Newsom and all 11 members of The Board of Supervisors, [the Controller], or the Mayor's office.'

The City desperately needs sound financial bond oversight, yet has irresponsibly failed to adopt or apply any of the Civil Grand Jury's bond oversight recommendations that were prepared in anticipation of the SFGH rebuild.

San Francisco charges the voters for steak and we always seem to end up eating hotdogs without a bun. Take a good look at this month's \$198.00 parcel tax increase in your property taxes. Proposition A's \$887.4 million cost is so expensive that San Franciscans can no longer afford to indulge the City's "business as usual" cost overruns on bond projects.

The City has had 14 years to plan the SFGH rebuild and has waited until the absolute last moment to present the SFGH rebuild to the public. San Francisco is falsely claiming that SFGH will

prepared to respond to traumatic injury and multi-casualty accidents and other incidents, such as that which the city will face in the next major earthquake. It also delivers state-of-the art medical care to all, regardless of station in life, keeping faith with the values of our city's namesake, Saint Francis of Assisi.

Staffed with physicians, surgeons and nurses affiliated with University of California San Francisco Medical School, General Hospital annually treats more than 100,000 people, receives more than 51,000 emergency room visits, including 29 percent of all ambulance traffic, performs more than 6,600 operations and delivers more than 1,200 babies. For more than a century, it has stood ready to respond to epidemic, most recently in the early 1980s when San Francisco General established the nation's first AIDS ward. Through its partnership with UCSF Medical School, General Hospital is the training ground for new generations of medical professionals and a fount of research for the advancement of medicine. It simply must be maintained and kept open for the good of all San Franciscans and beyond.

Critics have suggested there are other sources of money to pay for the rebuild. There are not. In fact, the general obligation bonds that would be authorized by Prop. A are the least expensive form of financing. Other financing mechanisms would bleed resources from vital public services such as police, fire and parks. Others have suggested the current hospital could be retrofitted to meet seismic standards – but such a course would cost at least as much money and would result in less space for patient care while creating new obstacles to adapting to future medical technologies. Still others have suggested the city could build a cheaper hospital. But the proposed building was designed based on current and future patient demand and industry best practices. What's more, delay begets cost increases – and threatens the very future of General Hospital.

The experiences of Californians elsewhere tell us the existence of public hospitals such as San Francisco General is not assured. Within the past 15 years, Sonoma, Fresno and Merced counties lost their public hospitals. Today, public hospitals operate in only 16 of 58 California counties. Generally, these hospitals were lost because of an inability or unwillingness of communities to support them at crucial points in their existence. We are at one of those crossroads in San Francisco.

To make the point, our campaign to pass Proposition A has introduce San Franciscans to people like rookie police officer Nick Ferrando, whose life was saved after a horrific traffic accident while responding to a crime scene, people like firefighter Dan Casey, who spent 13 days in General's Intensive Care Unit, 10 days of it on life-support, after suffering smoke inhalation while responding to a warehouse fire, and people like school board Commissioner Norman Yee, who had his neck broken by a red-light runner while crossing a street and was put back together by the neurosurgeons at San Francisco General. If you or one of your loved ones suffers traumatic injury, you are going to want General Hospital standing ready.

The doctors and nurses of General Hospital save lives everyday. It is time for San Franciscans to save San Francisco General by voting Yes on Proposition A.

not be rebuilt if the voters fail to pass Proposition A. This claim by the City is an emotional, scare tactic designed to trick voters. SFGH will NOT be closing if Proposition A is not passed. A new law, SB306 will allow San Francisco to complete SFGH by 2020. Responsible City's such as San Mateo finished the seismic retrofit of their hospital by 2002.

Many of Proposition A's current design problems and cost overruns could have been avoided if San Francisco had been more responsible to its voters

What was the Department of Public Health (DPH) thinking when they spent \$30 million planning Proposition A?

Construction is supposed to cost \$887.4 million. By the City's own admission construction may actually cost \$943 million. This \$55.6 million increase is open ended.

Furniture, fixtures and equipment (FFE) are supposed to cost \$75 million. In 2006, Anshen and Allen's SFGH feasibility study predicted that FFE would cost between \$157 million and \$234 million. It's interesting to note that the price of medical equipment has dropped so dramatically, while the costs of everything else continues to rise.

The debt service on the bond is predicted to be \$640 million. The sub-prime mortgage melt-down is paralyzing municipal government financing. San Francisco may face unprecedented delays in selling Proposition A bonds since the market for bonds has dried up. If the current economy conditions persist, the real story may simply be that the City will not be able to find buyer for it's bonds. Incredibly, there is no cap on Proposition A's bond interest rate and the bonds debt service may be underestimated by at least \$100 million or more. Bond interest rates will certainly increase and debt service will skyrocket.

The recent history of inflation for California hospital construction between 2003 – 2006 of 18.5% should also make voters wonder why the SFGH rebuild is planning for only 7% annual cost increases.

Cost estimates to rebuild the hospital have already increased by 30% or \$265.4 million in just two years. In 2006, San Francisco was planning to build a rectangular hospital for \$622 million. The hospital being presented to the voters now is an oval, glass-walled structure featuring private rooms and \$7 million worth of artwork. The less expensive rectangular hospital would have worked just as well, but may not have looked as nice. Just like the voters, San Francisco needs to start tightening its belt.

The City will also be spending hundreds of millions retrofitting the non-seismically retrofitted red brick buildings on the SFGH campus. Unfortunately, the new hospital will be located in the fall-zone of two of these antiquated buildings. San Francisco admits that the red brick buildings need to be retrofitted, but has arbitrarily decided not to retrofit the buildings until sometime after 2015. Voters can only wonder why the City is willing to risk the safety of the new \$1.6 billion dollar hospital that we will be paying for over the next 23 years. Common sense dictates that he red brick buildings need to be retrofitted before the hospital is built, not after.

San Francisco needs to create an independent body, staffed by professionals dedicated to responsible bond planning and management. Voters can no longer trust the City to monitor themselves.

The City should also give the taxpayer a break by applying the available Tobacco Settlement Revenue (TSR) to the cost of the SFGH rebuild. By 2015, San Francisco will have earned \$257.4 million in TSR funds. The City has already appropriated \$148 million in TSR funds to finance replacing Laguna Honda Hospital, leaving the City with \$109 million in TSR funds it could apply to rebuilding SFGH. The funds would help lower the cost of the SFGH rebuild to the voter. The City has never stated what they are going to use the TSR money for.

The City government has to do a better job representing the interests of the voters. Promises to voters must be kept, and voter's tax dollars must be spent wisely and intelligently. San Francisco voters are kind-hearted and giving, but we can't afford to see the City waste our tax dollars on another failed bond project. Let's wait and fix Proposition A's bond problems that the City's irresponsibility to the voters has created. Before voting, ask yourself if you believe that the City has been responsible with the taxes they are currently spending. Without responsible governance and the required changes to the Proposition A bond: Vote No on Proposition A!

#### West of Twin Peaks Central Council

The West of Twin Peaks Central Council (WOTPCC) meeting on Monday, October 27th was a spirited affair that ended up being focused mainly on city planning issues as San Francisco Planning Commissioner Mike Antonini gave an update on projects being considered by the Planning Department, as well as answering questions from the audience of approximately 30. Later, two of the three candidates vying for District 7 Supervisor addressed the group.

WOTPCC President Don Dutil opened the meeting be welcoming people and, after the approval of minutes, and the treasurers report moved into the guest speaker portion. As there was no representative from the SFPD present, the Police Report for the month was skipped. Dutil then introduced Planning Commissioner Antonini who proceeded to give an extensive overview of the current projects under consideration by the planning commission.

Antonini started his report by addressing the work that is being conducted on the 2009 Housing Element Document. This documents defines the "general plan" for housing in the city and is used by the city government to incorporate the feedback of the citizens into project planning and approval.

The commissioner stressed how important it is for the citizens to research the draft document and ensure that their true wishes are incorporated into the final document

(As a sideline, it was mentioned that Matt Chamberlain is serving as a citizen representative on the Community Advisory Body that is contributing to the 2009 Housing Element and has compiled extensive notes on the meetings. His notes can be found on the WOTPCC website at www.WestOfTwinPeaks.org). Judith Berkowitz also spoke about her experience on the CAB, and mentioned that the group has had their meetings behind closed doors, as the city feels there could be too many people attending in a public forum.

She stated that the next meeting for the CAB would be held on Wednesday, November 5th at 9:00 AM at the Planning offices located at 1650 Mission Street, in the Conference Room in Room 431. The public is allowed to attend.

Commissioner Antonini then addressed projects such as the redevelopment of the Eastern Neighborhoods, which encompasses approximately 20% of SF land. The project was submitted to the Planning Department, but with possible extensive changes being made to the project, it will have to be re-submitted to the department; the PUC rebuild of the Hetch Hetchy water delivery system, and a Whole Foods mixed use project near Kezar at Haight and Stanyan are in the process before the Planning Commission.

Antonini went on to discuss the role of the Planning Commission, and how they can impact general planning by enacting planning measures such as the "Formula Retail Ban" where cookie-cutter, "chain" stores are banned in certain areas to better protect the smaller, independent merchants.

Projects that are important to the WOTPCC community and other Westside residents were also discussed. Antonini noted that Supervisor Sean Elsbernd has proposed legislation that would create a process to examine the "Cumulative Effect" of projects to possibly better examine the environmental impact of multiple projects instead of looking at each project as an individual entity. Several speakers in the audience felt that this cumulative effect would make it easier for developers, but the final document is not yet completed. The project at 2400 Sloat Blvd. (John's Ocean Beach Café / Robert's Motel) was also discussed as Antonini said that the developer is making changes to the original plan, and a restyled project is slated for submittal to the Planning Commission in the next several weeks.

Other projects discussed were the Muni/BART Balboa Park station changes; and the Ardenwood project; as well as planned development at Hunter's Point, Treasure Island, and the Transbay terminal project.

Questions from the audience concerned the definitions of "Affordable Housing", "Inclusionary Housing", and the possibility of the 19th Avenue corridor being designated as a "Priority Development Area", which raised the specter of a project that would greatly increase density, reduce parking, and focus on mass transit options.

Following the summary and Q&A time with Antonini, Dutil introduced two candidates who are running for the District 7 Supervisor position that is currently held by Elsbernd.

Julian Lagos and Billy Bob Whitmer share similar backgrounds. Both are non-party aligned, running as independent's. The candidates are both against the

types of development that are being considered at Park Merced, Stonetown and on Brotherhood Way, and both stated that they feel the incumbent (Elsbernd) is too pro-development. Whitmer went on so explain that the big issue is that the city government has little or no accountability for its' financial spending and planning. Lagos stated that his campaign is gaining support and that he represents the working people in SF.

To be fair, Supervisor Elsbernd was not present due to a prior commitment, and could not reply to the claims of the two candidates.

With many development projects currently in the planning and review process, it is important to become more familiar with the scope and ramifications of each of the projects. We will cover more information in future issues of the Observer.

The next meeting of the WOTPCC will occur on Monday, November 24th at the Forest Hills Community Club House at 7:30 PM.

him in cash, which was the only terms under which Cudden would accept employment.

Frank Gallagher, media relations consultant, testified that he had worked with Scanlon on the Hall for Supervisor campaign in 2003 and that the checks from the campaign funds were for work Scanlon had done as Volunteer Coordinator and for her work raising funds for the campaign. He had "no doubt" that Ms. Scanlon was paid \$12,000 for services she had performed with the Irish-American community, and especially for her help with contractors. He further testified that the gas and food charges were for bone fide campaign expenses.

Eamon J. Murphy, construction contractor, testified that Scanlon solicited campaign funds from him for the newly-appointed Sean Elsbernd when he visited him in his offices in City Hall.

Peter Bagatelos, Hall's campaign attorney, testified that he had advised Hall about the use of gas and meals for the campaign, and that there should have been a proper accounting for each expenditure, but that those kind of expenses are not usually subject to charges, and amounted to "de minimis" errors. He said that the single expenditure, the charge for purses for his wife and daughters at a Virginia City leather shop, happened when Hall mistakenly used the wrong credit card.

He advised Hall to repay the \$320 to the campaign and to apologize for the error and offered to settle the gaff with Ethics with a small fine. His efforts to settle the minor problems did not meet with any response from Richard Mo, the officer in charge of the complaint, he said. Bagatelos charged that Mo had prejudged Hall's behavior before the investigation began, because Mo told him early on "Hall lied about expenditures and had intimidated witnesses."

Walking on the 2200 block of Taraval Street, you first see a sidewalk sign with a chalk message advising you to "Have a Great Day". This cheery welcome is the first sign that Sunset Pet Supply is a different kind of retail store.

No state has achieved California's status regarding high speed rail development for an eventual system extending to San Diego in the south and Sacramento in the north at an additional cost of approximately \$12,000,000,000. California voters

and Sacramento in the north at an additional cost of approximately \$12,000,000,000. California voters possess the power now to ensure federal and private funding by establishing the financial underpinning of Proposition 1A.

While opposition to Proposition 1A appears scattered and idiosyncratic, present-day vicissitudes in financial markets 3,000 or more miles from California cause some professional naysayers and even a few self-appointed journalistic sages to question affordability of Proposition 1A. A few iconoclastic critics, even in good faith and without the ideologue tenor of the Howard Jarvis Taxpayers Association (which succeeded in subverting the public's best chance of reforming governmental eminent domain powers in last June's statewide election) have expressed concern over whether the State's general fund can sustain repayment of bond holder investments in the Proposition 1A bond measure. To that concern, State Legislative Analyst Liz Hill and Treasurer Bill Lockyer conclude that Proposition 1A would not exceed the State's debtservice limitations under generally accepted public accounting practices that allow a maximum 6.5% of the State's general fund expenditures for annual bond payments. The so-called debt-service ratio currently stands at 4.4% for infrastructure bonds like Proposition 1A and is expected to increase to a maximum 6.2% in 2011-2012 as currently authorized bonds and the Proposition 1A bonds are sold. Therefore, California can afford Proposition 1A.

Secondly, and equally as important, at a time of economic need Proposition 1A represents the very best governmental policy to invigorate the economy. The California High Speed Rail Project will create approximately 160,000 construction-related jobs and about 450,000-460,000 permanent new jobs thereafter. The multiplier effect upon the economy will be prolific. History so teaches us, not just nationally in terms of President Franklin Delano Roosevelt's 1933 establishment of the Works Progress Administration (WPA), the Grand Coulee and Bonneville Dams, the Tennessee Valley Authority and similar public structure projects establishing employment for hundreds

of thousands of Americans. Commentators and economists dubbed such projects "priming the pump", as in giving life and energy to the economy. So, too, our forbearers in the Bay Area acted boldly and no differently. Reflect upon the fact that construction of the Golden Gate Bridge, based upon general obligation bonds supported by the counties of Marin, Sonoma, Napa, Mendocino, Del Norte and, of course, San Francisco, began in 1933 and culminated with the bridge opening in 1937. In that era of the same 1929 Wall Street collapse and later economic depression, the San Francisco-Oakland Bay Bridge was built. Think too about the Bay Area Rapid Transit District (BART) in November 1962 when a \$792,000,000 general obligation bond was approved by 60% and more of voters in Contra Costa, Alameda and San Francisco Counties. Those projects all confronted skeptical critics, plus the inevitable self-appointed experts who claim knowledge superior to recognized professionals. Yet the people of San Francisco, the Bay Area and Northern California persisted. Consider for a moment our transportation predicament if BART had not been built. Some 46 years later Santa Clara County clamors for inclusion and extension of BART to San Jose. It's axiomatic that every year of high speed rail delay produces an additional \$1,000,000,000 cost. An October 2008 study sponsored by the Bay Area Council forecasts 55,000 high speed rail project-construction related jobs in the Bay Area alone. The proper question is: can we afford NOT to build high speed rail?

Additionally, the project contributes mightily to California's legally-required mandate to reduce carbon dioxide emissions by 25% in 12 years, by 50% in 22 years, pursuant to 2007's Assembly Bill No. 32, enthusiastically signed by the Governor for good environmental reasons. High speed rail operates electrically, eliminating about 12,700,000,000 pounds of carbon dioxide emissions annually, using one-third the energy of air travel, one-fifth the energy of automobile travel and reducing foreign oil imports by 22,000,000 barrels per year. That's a reason the Sierra Club, San Francisco Tomorrow, San Francisco League of Conservation Voters, California League of Conservation Voters, Natural Resources Defense Council, Endangered Habitats League and Greenbelt Alliance, among others, support Proposition 1A.

in 2030 will comprise approximately 50,000,000 people. To absorb the transportation demands that high speed rail will satisfy by 65,000,000-105,000,000 rides annually, would require building 3,000 new freeway lane miles, 91 new airport gates and five new runways at a cost of two-three times the high speed rail project, which will remove nearly 70,000,000 passenger trips from our highways each year and attract millions of airline passengers, thus reducing airport delays. The economic benefits of the project constitute one reason for the support from the Greater San Francisco Chamber of Commerce, the Bay Area Council, the Redwood City-San Mateo County Chamber of Commerce, the Sacramento Chamber of Commerce, the Oakland Chamber of Commerce, the San Jose/ Silicon Valley Chamber of Commerce, the Fresno Chamber of Commerce, the Greater Stockton Chamber of Commerce, the Long Beach Area Chamber of Commerce, the Los Angeles Area Chamber of Commerce, the North Bay Leadership Council, the Orange County Business Council, the California Alliance for Jobs, the California Labor Federation, the California Nurses Association, the San Francisco Labor Council, the International Union of Operating Engineers, the San Mateo County Central Labor Council, the California Professional Engineers in Government, the National Association of Railroad Passengers, the San Francisco Board of Supervisors, the California Transportation Commission, the City/County Association of Governments of San Mateo County, the Metropolitan Transportation Commission, the North Coast Railroad Authority, the League of Women Voters, San Francisco Planning & Urban Research, the American Lung Association, California Federation of Teachers and the Kern County Taxpayers Association and Sacramento City Taxpayers' Rights League, together with federal, state and local elected officials from U.S. Senator Dianne Feinstein to the mayors of San Francisco, Los Angeles, Fresno, San Jose, San Diego, Bakersfield and political organizations such as the San Francisco Democratic County Central Committee and the San Francisco Republican County Central Committee. Forty years from now our descendents will thank us for finally producing a high speed rail system like those in 11 other nations, starting with Japan for the 1964 Olympic Games. Like California's Argonauts of the 19th Century, our cry for Proposition 1A is "Excelsior." Vote accordingly.

Afghanistan: Hidden Treasures from the National Museum, Kabul October 24, 2008– January 25, 2009 Asian Art Museum

Extraordinary artifacts uncovered in modern-day Afghanistan, long thought stolen or destroyed during some twenty-five years of conflict until the dramatic announcement of their existence in 2003, make their only West Coast appearance on their United States tour at the Asian Art Museum of San Francisco, October 24, 2008, through January 25, 2009. Revealing the multicultural heritage of Afghanistan—once the heart of the Silk Road linking cultures from Asia to the Mediterranean—are some 228 objects ranging

in date from 2200 BCE to the second century CE. The artworks are mainly drawn from three archaeological sites, together with a few earlier works providing background. These artworks which belong to the National Museum, Kabul, include fragmentary gold bowls with artistic links to the cultures of ancient Mesopotamia (largely present-day Iraq) and the Indus valley (largely present-day Pakistan) from the Bronze Age site of Tepe Fullol; bronze and stone sculptures and a gilded silver plaque from the former

Greek colony at Ai Khanum ("Lady Moon"); bronzes, ivories, and painted glassware that had been imported from Roman Egypt, China, and India, and excavated from ancient storerooms discovered in the 1930s and 1940s in Begram; and more than one hundred gold ornaments from the "Bactrian Hoard," found in 1978 in Tillya Tepe, the site of six nomad graves, which reveal a synthesis of Greek, Roman, Persian, Indian, Chinese, and Siberian styles.





Ed Harris: Virgil Cole (hired as marshal of a New Mexico hamlet by townsman Timothy Spaal to end the reign of cold-blooded killer, rancher Randall Bragg: Jeremy Irons) also directs with a touch of humor, co-produces and cowrites this western, even sings a song during the end credits. His deputy, Everett Hitch: Viggo Mortensen, travels with him everywhere. Allison, a genteel lady (Renee Zellweger) arrives in town and plays folk tunes on piano at the local saloon. Shia LeBeouf and Michelle Monaghan both receive mysterious foreboding calls on their cell phones. The female voice gives them seconds to make decisions that will involve explosions, car crashes, the fate of loved ones. Thrown together to save their own lives, they try to outwit the unseen allknowing technology-assisted protags. Their appointments keep them on the go in fast action sequences throughout the Eastern U.S. in this brilliantly edited techno-thriller. Language, action violence. DreamWorks/ Columbia 108

Mark Wahlberg in the title role is a DEA agent whose family was killed. He joins with Mona: Mila Kunis, a vengeful sister, to bring down those in NYC responsible for the drug enhancing Valkyr. His wife's boss, Jason: Chris O'Donnell, is forced to reveal what he knows. The Aesir Pharmaceuticals execs, B.B.: Beau Bridges and Nicole: Kate Burton, are more involved than they want to admit. Based on a video game, directed with flair by John Moore and written by Beau Thorne. Some sexuality, drug use, extreme violence. 20th Century Fox 99 min.

#### MIRACLE OF ST. ANNA

Director Spike Lee, convinced that Blacks haven't been receiving enough screen-time in recent war films, has concentrated his James McBride (novel and screenplay) tale in Tuscany with a black battalion misplacing four of its soldiers behind enemy lines in 1944. The foursome are portrayed by Derek Luke: 2nd Staff Sgt. Aubrey; Michael Ealy: Sgt. Bishop; Laz Alonso: Corp. Hector; and Pvt. 1st Class Sam: Omar Benson Miller. As they befriend the townspeople who hide and feed them, everyone gets acquainted. There's the wrap-around story of a shooting in a post office with Joseph

Gordon-Levitt as reporter Tim Boyle and John Leguizamo as Enrico. Touchstone 160 min.

#### NICK & NORAH'S INFINITE PLAYLIST

Nick (Michael Cera: Juno) compiles CDs of music specially for his love, Tris (Alexis Dziena), who has little interest in him until her bgf Norah (Kat Dennings: The House Bunny) realizes she and Nick have the same music tastes. Director Peter Sollett presents one night with New Jersey teenagers falling in and out of love in Manhattan. Lots of laughs. Teen drinking, sexuality, language, crude behavior. Columbia 90 min.

The title is a combination of the words 'religious' and 'ridiculous'. Religulous is directed by Larry (Borat, Curb Your Enthusiasm, Seinfeld ) Charles, and written by Bill Maher who takes short, quick stabs at all religions, moving on too fast. Geo. W. Bush (Josh Brolin) meets Laura (Elizabeth Banks) at a barbeque. Barbara Bush (Ellen Burstyn) tries to



keep hubby, Geo. H.W. Bush/Poppy (James Cromwell) under control. Barbara to W.: "You're loud and you've got a short fuse." The inner circle members include Dick Cheney (Richard Dreyfuss), Karl Rove (Toby [infamous as Capotel Jones), Condoleeza (Thandie Newton), Rumsfeld (Scott Glenn), and Colin Powell (Jeffrey Wright), plus there's Tony Blair (Ioan Gruffudd). #### Got Stress? and how to manage it

With all of the seriousness today, the economy, election, and regular day-to-day stuff, let's take a break and have a little laugh.....

Dr. Madan Kataria, better known as the Guru of Giggle, is the creator of Laughter Yoga Int'l. There are now 5,000 laughter clubs around the world, www.laughteryoga.org. See it for yourself at You-Tube.com. Laughing decreases stress hormones and increases endorphins. Breathing and laughing improves health even if the

laugh is faked. No jokes or punch lines, you don't even need to be happy. Just start laughing - belly laughing, if you can. Laughing puts us in the moment. When we're present, not the past or worried about the future, we are being, Human Being!

Quote: "Imagination was given to us to compensate for what we are not; a sense of humor was given to us to console us for what we are" – Mark McGinnis

#### What is Stress?

We'll never be without stress in our lives. Stress let's us know we're alive. It's an important and normal part of existence. This Fight or Flight instinct is built into all living beings to stay alive and protect the species from predators. It's the circle of life, the food chain.

If we're in a tough situation, there are two choices, to stay and fight or run and take flight. Both choices require a huge chemical shift on the cellular level. The body goes into a "temporary" altered state of protection where our Will To Live is so great; we gain strength and power beyond our normal means. For instance, the mother whose child is pined under a car tire is able to lift the car to free her child. She isn't able to sustain this power but doesn't need to. The key word here is "temporary".

#### **How Nature Handles Stress**

An analogy taken from Eckhart Tolle, author of *The Power of Now:* 

Imagine ducks swimming in a pond. These birds are territorial and usually mate for life. Here comes a young male feeling his wild oats and paddles over too close to a female who's already spoken for. Her mate goes after the young duck and the two males get into a flapping, honking and biting match. They rise up out of the water and go neck and neck for a minute or two until the young one backs off. They drift apart, creating space between one another. Then you see the ducks flap their wings ferociously back and forth with great power. They're expelling the left over energy from the squabble. They then swim away, wiggling their tails and settling back down calmly and peacefully. The stressful situation is OVER.

The older duck doesn't swim away in a huff, telling the other ducks watching, "Did you see that young stud trying to pick up my girl? The nerve of him...if he swims around here again, I'll break his neck!" and so on, holding onto it for days or maybe even weeks, telling every duck he comes in contact with. No, when the confrontation is over, the duck flaps his wings and he's done. He floats away, enjoys the beautiful sunshine and looks for his next meal.

If we were back in the Cave Man days, this duck analogy might make more sense, ay? Well the thing is, we

do still have these basic instincts that drive us and take over without our awareness. Our lives are "civilized" now and we don't have to worry about being eaten by the big fish, or do we?

Our psyche on the cellular level doesn't really know the difference.

What happens when the boss says, "If you don't make your numbers next quarter, I'll have to let you go." Or when a spouse announces they've found someone else and wants a divorce. The instincts take over and suddenly we're in survival mode. "What

happens when banks close their doors with our money inside? Who'll run the country and get us out of debt? Who'll end the war and stop the killing?" and on, and on, and on.

Humans are different from the rest of the animal kingdom. We have thinking, reasoning brains. When a situation arises, we think about it, think about it and think about it some more. These thoughts become cumulative and the worse it gets, the worse it gets. One more thing goes wrong and it's the straw that breaks the camels back. Not able to sleep at night without sleeping pills? Take anti-depressant drugs during the day to feel good? STOP!

#### **Body Chemistry**

When we're in Fight or Flight stress mode, our body becomes highly ACIDIC. This throws off the PH balance in the body. We can take the best vitamins and eat all the healthy food we can afford but if we're stressed, none of it matters. Stress is now known to be a significant factor in over 80 percent of all illnesses. Stress is a killer. "let's become aware of our Emotions. Stress creates acid and an imbalance in the blood, (blood becomes thick and not able to oxygenate the body) which zaps energy, messes up our health and our life." taken from my July 08 article, Why Can't I Lose Weight, Alkalize and Energize at www.westsideobserver. com/columns. When we manage stress levels, some great side effects are lower blood pressure and cholesterol, less headaches, less joint aches and pains, and how about just feeling happy!

# When Does a Person Become an Adult?

When I grew up in New York in the 40s and 50s, there were many different definitions of the age and nature of adulthood. We were adult



enough to drive at 16, to drink at 18, to join the Army without our parents' consent at 17, and to marry in the South at 14. If we were Jewish, we were considered adult at 13. But no matter what our affiliation, most things required the age of 21 for adult responsibilities. We had to be 21 to vote, buy cigarettes, sign a contract, or do a real estate transaction.

Today, many people consider anyone over 17 years of age to be adult, with all the rights and responsibilities that entails. Except, in order to buy and use alcohol, buy a lottery ticket, or sign a real estate contract, you have to be over 21.

The problem is that now anything these teenage "adults" do (they used to be called "minors") or decide is between them and the organization or person involved. For anyone else, the information, be it medical, academic, or financial, is confidential. Isn't this good? Aren't we all scared to death that someone will get some vital information about us against our will?

What if your 19 year-old daughter is away at school and is hospitalized? You are her parents, love her, and pay all her bills. But you have no right to know what happened to her. Maybe she has a learning challenge,

is shy, or naïve. It doesn't matter, she's an adult.

Your son is a freshman at college. He is doing badly in school and is having serious adjustment problems in the dorm where his assigned roommate has a major psychological condition such as obsessive compulsive disorder. You call the school to plead for intervention. The response is that your son is an adult and should be able to deal with it.

You find out the day before that your 20 year-old daughter has contracted for an elective, and seemingly unnecessary surgery. She signed papers promising to pay an exorbitant amount with no option for a refundable cancellation. The daughter acted on a whim and is now caught on the hook. The doctor did not counsel the patient or contact the parents. The 20 year-old is an adult and therefore can make her own decisions about her own body.

While, nowadays 16 year-olds can still get a driver's license, the age at which they are considered adult enough to drive at night and other passengers keeps getting increased because there are so many auto accidents among this "young" adult group.

At the same time, medical science believes that for most people, the frontal lobe of the brain, which controls adult thinking, like strategic planning, prioritizing, seeing short and long term effects of possible actions and decision making, is not fully developed until the age 25. The physiological adulthood starts at 25.

I suggest we make 25 years and older the age of legal adulthood. That would mean that in order to drink alcohol, place a bet, cast a vote, sign a real estate contract, buy a gun, or have personal medical or academic information kept confidential from the family,

a person must be at least 25, which is the new 18 just as 62 is the new 50.

I think that this idea not only makes biological sense, but makes social and economic sense, too. Under this new system, high schools and colleges could no longer hide their accountability behind the backs of adults too young to know better. Doctors and hospitals would be accountable to the authorized adult who is already responsible for paying the bill. Teenagers would no longer be expected to study the 20 or 30 ballot arguments in order to vote intelligently. And think of all the alcohol-related deaths caused by premature and immature intoxication, that could be avoided by extending the minimum age by four years? Maybe some of these young people will never even start drinking. Imagine that, sober adults!

But what about the argument that if a person is old enough to join the Army and kill or be killed in the country's defense, he or she should be old enough to drink and smoke cigarettes and do all the other things adults can do? (Or the older case that if a person is old enough to make a child - 13 or so - he or she is old enough to be an adult?)

The answer is late them wait until they are 25.

But then the question arises: What if not enough people over 25 were willing to fight and die as young men did in Viet Nam and Iraq?

The answer is then maybe we won't go to war as often, but at least we won't have to hear how many teens have lost their lives or limbs before having had the chance to enjoy a little more life

If heaven can wait, why can't adulthood?

#### VERA WILDE

Shotgun Players' Vera Wilde Connects Mavericks Oscar Wilde and Vera Zasulich. Although aesthete Oscar Wilde and 19th century revolutionary Vera Zasulich never met, they had several traits in common that made them an inspiration to one another. They both attempted to introduce change in a conservative environment and both had the courage and will to stand up for human rights. And although these two prominent 19th century writers came from very different backgrounds and cultures and led lives on opposing social levels, Seattle playwright Chris Jeffries has managed to bundle them together through common ideals that gradually changed society's views on homosexuality and leftist politics.

It's a lively musical with book, songs and music that revolves mainly around Wilde's admiration for Vera's heroic stand against the inhuman and despotic treatment of a sick prisoner who, after failing to remove his hat before General Trepov, was ordered to be harshly thrashed. Vera attempts to kill the General, is arrested and a jury's acquittal of her deed, triggered Wilde's creation of his first play, Vera the Nihilist, in 1880. Although the performance of the play in 1883 was a flop, it brought about social and political repercussions.

When Vera, of poor nobility, is sent to a school to be a governess she becomes involved with a neighboring radical group and is imprisoned for her radical views. After she is acquitted for shooting General Trepov she escapes to Switzerland where she writes articles on the working class in Russia, meets Lenin and is a member of the Russian-Social Democratic Labor Party. She returns to Russia in 1905 where she opposes the Bolshevik Revolution and dies in 1919.
